

Wise Owls Nursery School has regard to the <u>Prevent duty 2015</u>. This duty works alongside other safeguarding policy and practice as required by <u>Working Together to Safeguard</u> <u>Children</u> (DfE 2018). The Designated Lead for safeguarding has oversight of the Prevent duty at our setting.

The Prevent duty aims to stop people becoming terrorists or supporting terrorism and to keep children safe from associated dangers.

## 1. Risk assessment

If staff have concerns for the welfare of a child they complete a 'Cause for concern' and report to the Designated Safeguarding Lead or Deputies who will contact the Front Door for Families, Tel: 01273 290400.

We will support our staff to feel confident to recognise signs of people at risk of being recruited by terrorist or extremist groups through accessing advice via the BHSCP. All staff complete training on The Prevent Duty during our induction procedure. We use the following online course.

National NDNA advice suggests that staff are alert to:

- Changes in family behaviour
- Changes in the children's behaviour, e.g. aggression towards others
- Comments made by a child which may cause concern, e.g. commenting on what their mummy or daddy has said, talking about fighting for 'the cause' etc.
- Comments made by family members, e.g. about certain faiths, beliefs, cultures
- Any other signs that family members may be showing extremism
